**SANDY HIGH SCHOOL DRIVER EDUCATION
RELEASE, WAIVER, AND INDEMNIFICATION**

The undersigned participant and his/her parent or legal guardian (if under the age of 18 years of age) does hereby execute this release, waiver and indemnification for himself/herself and his/her heirs, successors, representatives and assigns; and hereby agrees and represents as follows:

To release the Sandy High School, its members, employees, agents, representatives and those governmental agencies and other organizations affiliated with this course from any and all liability, loss, damage, costs, claims and/or causes of action, including but not limited to all bodily injuries and property damage arising out of participation in the driver education course referred to above, it being specifically understood that said program includes the operation and use by the undersigned participant and others of automobiles. The undersigned further agrees to indemnify the Sandy High School, its employees, members, agents, representatives and those governmental agencies and other organizations affiliated with this program, and hold them harmless for any liability, loss, damage, cost, claim, judgment or settlement which may be brought or entered against them as a result of the undersigned's participation in said program. This indemnification shall include attorney's fees incurred in defending against any claim or judgment and incurred in negotiating any settlement. It is understood and agreed that the undersigned shall have the opportunity to consent to any such settlement, provided, however, that such consent shall not be unreasonably withheld.

IMPORTANT-PLEASE READ!!

Under Oregon law, schools shall receive reimbursement only for those students who have completed the traffic safety education course prior to issuance of the provisional driver license. Those students that acquire their provisional driver license or reach the age of 18 before completion of the program must pay an **additional \$210**. All students will be required to show their instruction permit to the program coordinator in exchange for their Certificate of Completion.

In case of course failure, suspension, or expulsion, a student must pay the entire fee again in order to re-enroll into the next available DE class. Attendance is mandatory for specified hours. Students failing to attend scheduled classroom and driving appointments will be dropped from the program with no refunds.

Textbooks are provided. A fee of \$25 will be charged for damaged or lost texts.

All additional fees must be paid before issuance of Certificate of Completion.
